- 2251 N. Lake Drive (North Point South Historic District) Reline three fireplace chimneys. Two located on the first floor and one located on the 2nd floor, south side. Replace chimney cap and six courses of bricks of chimney on the north side of home. Tuckpoint entire chimney. Applicant: Lise & M. Shyam Sadagopan. PTS# 60334 Issued 7-29-2009.
- 2. 2802 W. McKinley (Cold Spring Park Historic District) Install a High Efficiency boiler in basement and vented with 3 inch PVC pipe on the East side of the home and painted to match home. Applicant: Affordable Heating and Air Conditioning. PTS# 60318 Issued 7-29-2009.
- 3. 3039-41 N. Sherman Blvd. (North Sherman Blvd. Historic District) Replace damaged aluminum storm windows with matching windows. Replace missing 2nd floor rear jump / airing porch. Replace front service walks. Rebuild east side brick wall of front porch. Rebuild column to left of south side of porch using the original brick or a staff approved equal. Paint all window sashes. Remove vinyl sided wall and storm door added at outer front entry. Install steps and guardrails around 2nd story porch. Applicant: Carl Quindel. PTS#60136 Issued 7-29-2009.
- 4. 924 E. Clarke St. (St. Casimir Church Complex) Install half light aluminum doors and frame to match existing windows. Install a reinforced concrete ramp with black rails to match existing.
