The undersigned complainant, on information and belief, being first sworn, on oath, states:

### Count 1: POSSESSION WITH INTENT TO DELIVER METHAMPHETAMINE

The above-named defendant on or about Monday, June 25, 2018, Polk County, Wisconsin, did possess with intent to distribute a controlled substance, to-wit: Methamphetamine, in an amount of more than 50 grams, contrary to sec. 961.41(1m)(e)4 Wis. Stats., a Class C Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

### Count 2: POSSESSION OF METHAMPHETAMINE

The above-named defendant on or about Monday, June 25, 2018, Polk County, Wisconsin, did knowingly possess methamphetamine, contrary to sec. 961.41(3g)(g) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 3: POSSESSION OF SHORT-BARRELED SHOTGUN OR RIFLE**

The above-named defendant on or about Monday, June 25, 2018, Polk County, Wisconsin, did possess a short-barreled shotgun, contrary to sec. 941.28(2) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

**Count 4: POSSESSION OF NARCOTIC DRUGS**

The above-named defendant on or about Monday, June 25, 2018, Polk County, Wisconsin, did knowingly possess psilocybin mushrooms, a controlled substance included in Schedule I or Schedule II which is a narcotic drug, contrary to sec. 961.41(3g)(am) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 5: POSSESSION OF A CONTROLLED SUBSTANCE**

The above-named defendant on or about Monday, June 25, 2018, Polk County, Wisconsin, did knowingly possess Tramadol, a controlled substance, without a valid prescription, contrary to sec. 961.41(3g)(b), 939.61(2) Wis. Stats., a Misdemeanor, and upon conviction may be fined not more than \$500 or imprisoned not more than 30 days or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

**Count 6: POSSESSION OF DRUG PARAPHERNALIA**

The above-named defendant on or about Monday, June 25, 2018, Polk County, Wisconsin, did knowingly possess with primary intent to use, a pipe to inhale a controlled substance, contrary to sec. 961.573(1) Wis. Stats., a Misdemeanor, and upon conviction may be fined not more than Five Hundred Dollars (\$500), or imprisoned for not more than thirty (30) days, or both.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

And prays that said defendant be dealt with according to law; and that the basis for complainant's charge of such offense is:

Your complainant is employed by the Polk County Sheriff's Department and in said capacity has access to the reports filed by Officer Mariakis of the St. Croix Falls Police Department.

## PROBABLE CAUSE

In his report, Officer Mariakis states on June 25, 2018 at approximately 0330 hours, he was on routine patrol when he observed a vehicle he recognized to be a white Cadillac Escalade traveling east in the City of St. Croix Falls, within Polk County, Wisconsin.

Mariakis states information previously provided to him was to be on the lookout for a white Cadillac Escalade that was associated with a residence in the 800 block of North Hamilton Street in St. Croix Falls that is associated and owned by a subject that is known to be moving narcotics in the area and known to be carrying firearms. Mariakis states this information was provided to Officers and the local drug task force by reliable sources. Mariakis states in earlier weeks, Officers observed the vehicle parked at the residence of 811 N Hamilton Street in St. Croix Falls and is registered to Adam Gonet.

Mariakis states the Escalade he observed was traveling at a slow rate of speed and Mariakis activated his radar and it displayed a reading of 20 mph in a 45 mph zone and as the vehicle continued past him he observed the rear of the vehicle to be black. Mariakis states he turned around and caught up to the vehicle and observed the vehicle had no operable license plate lamp. Mariakis states he ran the registration on his MCD and the return came back to **Adam Gonet**.

Mariakis states while he walked to the vehicle, he had observed a brown leather pistol holster in the passenger seat back. Mariakis states upon contact, the driver, later identified as **Adam Gonet**, he observed Gonet was extremely nervous and sweating and would not look at him. Mariakis states Gonet was shaking while handing over his license. Mariakis asked Gonet if he had any firearms in the vehicle and Gonet immediately looked down at the center console and then to a purple bag laying against the passenger seat and stated, "No" but would not look at him. Mariakis states based on training and experience, he knows that suspects will "eye target" objects that they know officers are asking about.

Mariakis states in the passenger seat he observed a black zipper container with a lock on it and asked Gonet what was in the locked container and he replied it was his toiletries. Mariakis states also located in the passenger compartment was a purple cloth bag resting from the floorboard at an angle to the seat and when asked what was in the bag, Gonet immediately reached for it and he advised him not to grab the items and stated it was approximately 20-25 inches long and was rigid.

Mariakis advised Gonet to place his hands on the steering wheel as he was very fidgety inside the cabin and moving around.

Mariakis states he observed bulges in Gonet's pockets of his jeans and based on training and experience, he recognized one of the items to be a meth pipe and states it was approximately 5 inches long and had a ball on the end and the rest of the body was skinny.

Mariakis states he asked Gonet where he was going and he stated to a friend's house nearby and when asked where he was coming from Gonet replied, "St. Croix Falls". Mariakis states he asked Gonet if he was coming from the place on North Hamilton Street and Gonet looked at Mariakis and appeared perplexed but answered "Yes". Mariakis states he asked Gonet if he lived at there and he stated, "Yes, I stay there".

Mariakis asked Gonet if he had anything illegal in the vehicle and Gonet looked away then back and stated he may have a pipe in his pocket. Mariakis advised Gonet to place his hands on the steering wheel for his safety as well as Gonet's safety. Mariakis states he made contact on the driver's side and Gonet stated he had some meth in his pocket as well.

Mariakis advised Gonet he was placing him in handcuffs and advised Gonet he was being detained. Gonet then gave Mariakis consent to retrieve the items out of his pockets and he located a meth pipe and a silver canister which contained a clear/white crystal substance inside that Mariakis recognized to be methamphetamine.

Mariakis states the methamphetamine weighed 10.4 grams and did field test positive for methamphetamine.

Mariakis states also located on Gonet's person was \$2461 in US currency.

Gonet was advised he was under arrest and Mariakis read Gonet his Rights. Gonet advised he had 2 firearms in the vehicle and advised the location where they were and added one pistol was near the driver's seat and center console and the other was a shotgun that was in the purple bag that Mariakis had asked Gonet about. Mariakis states both firearms were loaded with a round in the chamber.

Gonet also advised there was a large amount of meth inside a tan container in the center console.

Mariakis located the container containing a large amount of suspected methamphetamine and states it weighed 46.9 grams and field tested positive for methamphetamine.

Mariakis states located in a zipper bag on the passenger seat was 8.9 grams of methamphetamine that field tested positive for methamphetamine, 6 Tramadol pills with no located prescription for Gonet and 7.3 grams of psilocybin mushrooms.

Murphy states the loaded shotgun recovered had an overall length of 24 inches and the barrel was less than 12.5 inches long.

Based on the foregoing, the complainant believes this complaint to be true and correct.
