2020 FEMA Disaster Funding for Lakefront Storm Damage -INFO

Issue

Informational update on efforts by Milwaukee County Parks to acquire Federal Disaster Funding for Storm Damage in January of 2020.

Background

On January 10-12, 2020 Milwaukee County experienced significant storm damage along the Lake Michigan coast as a result of both historically high water levels and damaging wave action. Parks, the Department of Administrative Services — Architecture and Engineering Division, and the Milwaukee County Office of Emergency Management (OEM) have been working with FEMA to ascertain what resources through disaster funding may be available to clean up, repair, and mitigate the damages experienced. The January storm event has been declared a Presidential Disaster, therefore Parks worked throughout 2020 with both FEMA and the Wisconsin Department of Emergency Management (WEM) to coordinate regarding eligible damages. Work has included submission of a detailed damage summary, definition of project scopes, weekly meetings, and site inspections. Projects eligible for FEMA funding have a total budget breakdown of 75% Federal, 12.5% State, and 12.5% Local share. Awarded projects will be matched with Parks Operating Funds in order to advance project work. Funding needs and project statuses as of the date of this report are detailed in the following table.

Milwaukee County Parks is in the process of filing a partial appeal for the South Shore Breakwater denial. WEM and FEMA have 60 days to consider any such appeal.
