To all our Partners:

The Milwaukee County District Attorney has advised our Department that his announcement from the OIS incident in Wauwatosa will occur on Wednesday afternoon, October 7th, 2020. In anticipation of civil unrest that may occur after this announcement, emergency Operations in Wauwatosa will begin that same day at 4pm.

Any law enforcement agency that has committed resources to this operation is asked to follow the below steps:

1. Respond via email to this mutual aid request acknowledging receipt: email us at WUPDCP@wauwatosa.net.
2. **Event Duration:** the WUPD has established Ops plans for a 7-day event and have scheduled mutual aid resources for that time frame. Incident Command will determine the operational duration within the first week. Rest days have been built in if operations need to extend beyond 7 days.
3. **Nightly Check In:** all personnel should report to the incident staging area and check in starting at 4pm each night.
 - a. Have a rep from your agency fill out and bring the attached "Mutual Aid Nightly Roster" each night
 - b. Clarify if the responding personnel are: Tactical, crowd control, or general LEO assistance
 - c. CP and Staging Area is located at the [REDACTED]
 - d. Enter from the south off of [REDACTED]
 - e. WUPD Staff will receive responding personnel and direct in for parking & check in
4. **Nightly Briefing:** Briefings will start at 5pm in the CP's roll call room for all personnel assigned to Tactical Units, Crowd Control Units, LE Mutual Aid & Security assignments.
5. **Radio Channels:** LEO's will be using OASIS radio channels. Some will be encrypted for tactical safety.
 - a. Designated radio channels will be declared at nightly briefings for each operational group
 - b. Additional radios will be available for LEO's that cannot access the designated OASIS channels
6. **Staging Areas:**
 - a. Break rooms, rest areas, a nightly meal, snacks, and water will be provided at staging locations
7. **Safety/Equipment:**
 - a. Unified Incident Command (UIC) will be established each night for command and control
 - b. Tactical & Crowd Control Rules of Engagement have been established
 - c. LEO's will be doubled-up on assignment for Officer safety
 - d. LEO's should bring all equipment available: helmet, riot baton, shield, gas mask, gloves
 - e. Additional crowd control equipment will be on hand to provide to Officers if needed
