**NARRATIVE****Assignment**

On 10-9-20 I, PO Stephen Schmidt, was assigned to assist with the civil unrest operations occurring in the City of Wauwatosa. Sgt. Kurt Svatek, PO Robert Piehl, PO Dan Mitchell, and myself were assigned to an unmarked patrol squad which was equipped with emergency lights and sirens. I was outfitted in a green uniform with exterior body armor which had "POLICE" prominently displayed on the front and back. Additionally, I was wearing a green baseball hat with "Wauwatosa Police Special Response Team" displayed on the front.

**Initial Call**

On 10-9-20 at approximately 8:30 PM officers were advised that unknowns subject/s may be attempting to start fires in the area of N. Lefebber Ave./W. North Ave. Numerous officers responded and observed numerous individuals in the area. Several subjects were observed behind a dumpster. Upon police arrival those subjects attempted to push the dumpster toward police. The subjects then scattered and fled. Between 5-7 of those subjects ran n/b. See Wauwatosa PD case # 20-18482 for more info.

**Area Check**

Numerous officers conducted an area check for the subjects that ran n/b. During the course of the area check officers observed the subjects running into residential yards and cutting between houses to flee from police. At approximately 9:00 PM Det. Tim Warren observed five subjects walking n/b in the 2500 block of N. Lefebber Ave. Det. Warren maintained constant visual of the subjects as they continued walking. They eventually turned w/b on W. Hadley St. from N. Lefebber Ave.

**Arrest**

We located the five subjects walking w/b in the 7200 block of W. Hadley St. We activated the emergency lights on our squad to initiate a stop. Upon seeing us, all of them fled. Three ran s/b in the alley between N. Lefebber Ave. and N. 73 St. Two of the subjects fled e/b and then s/b through yards on the west side of N. Lefebber Ave.

PO Daniel Mitchell and I pursued the two subjects who fled s/b on N. Lefebber Ave. and eventually took them into custody. PO Mitchell arrested Jacqueline L. Bogenberger (F/W, 5-9-91) in the yard at 2775 N. Lefebber Ave. I arrested Angel Vega-Anguiano (M/W, 12-22-90) in the yard on the south side of 2763 N. Lefebber
