Our PD is planning a large operation for civil unrest that could occur AFTER our DA announces an anticipated clearance of PO Mensah for the February OIS. (b) (7)(E), (b) (5), (b) (6), (b) (7)(C), (b) (7)(F)

DA Chisolm will give me 7 days advanced notice WHEN the clearance news will come out. It is my intent to then run a 7 day operation, heavy on the 4p-12a hours, to deal with civil unrest. Our own staff will be on emergency shifts to accommodate our operations. I will notify all our partners the day I hear from the DA's office, so they all have 7 days to prep for it also.

I am NOT asking for an official commitment at this time. However, you have offered help in the past, and depending on your work/rest from Kenosha, you are welcome to assist here also. I will let you talk over the details with (b) (6), (b) (7)(C), (b) (7)(F) as to what resources you can offer (likely arrest teams and vehicles?).

There likely will be a Zoom meeting on Thur afternoon for us to present our own plans, and then seek resources from our partners. If you would like to be included, I can forward the Zoom invite.

See the zoom link below for a special Milwaukee County Law Enforcement executive meeting on Thursday, 8/27, 1pm. This is being provided to other partners who have graciously extended resources to help with civil unrest in Tosa.

The meeting will present the preparation the Wauwatosa PD has in place for special operations that will start the day the Milw. County DA releases his findings on the Officer Mensah OIS from Feb. 2020. We anticipate civil unrest due to the release of these findings, which will be released in coordination with the MPD Homicide Team through a recorded community briefing.

DA Chisolm has NOT advised of when he will release his findings. Clearly the Kenosha civil unrest has slowed down the timeframe of this release. DA Chisolm will notify our PD with 7 days advanced notice of when the release will actually occur. This will allow all participating partners 7 days to prepare resources and staff.

I will highlight in detail during the meeting the resources and assistance our agency is requesting of our LE partners in the area.
