information is not intended to describe a specific or credible threat to SE WI. It has been shared because it describes a tactic used recently by violent extremists in the U.S. against law enforcement.

- It is still unclear how the ambush initiated. (Initial reports were that it was a drive-by shooting but still working to confirm.) Davenport Police Depart. (DPD) reported a DPD officer was shot and wounded early Monday in an attack they described as an ambush. Early Monday morning violent opportunists were engaged in what DPD dubbed a "mobile riot." Using coordination, individuals would quickly meet at a location via vehicle, vandalize property and attempt to vacate the area before police could respond. The ambush occurred while DPD responded to one such event around 3 a.m. Monday morning.


