There are still two other people who still need to be arrested on homicide charges in the Joel Acevedo murder. [REDACTED] who is [REDACTED] on Port Washington Rd. These men were holding Joel down while officer Michael Mattioli choked him to death as Joel begged them to allow him to go home this past April. They jumped Joel and were all involved in taking his life. The corrupt Milwaukee DA's office is trying to use the two men as witnesses for officer Mattioli to get him off for the murder of Joel Acevedo.


This is no different from the other officers being arrested for being involved in the wrongful death of George Floyd. These men were not tested for drugs and alcohol and able to leave the scene with out being arrested. Mind you this was a Cop house party with alcohol and drugs during a safer at home order. Witnesses even say that they saw a stripper leave running from the house that night.

Some witnesses estimate there were a dozen or more people at the party.

This is so wrong and we the people can't allow this. The police murder has to stop and the DA's office is working on behalf of the killer cops. Also they won't release the body cam footage or the 911 call of that night which shows Joel was pleading for his life while being murdered by these 3 individuals. We want [REDACTED] arrested immediately and the body camera footage and 911 call released now.

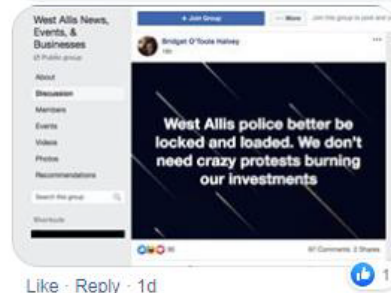

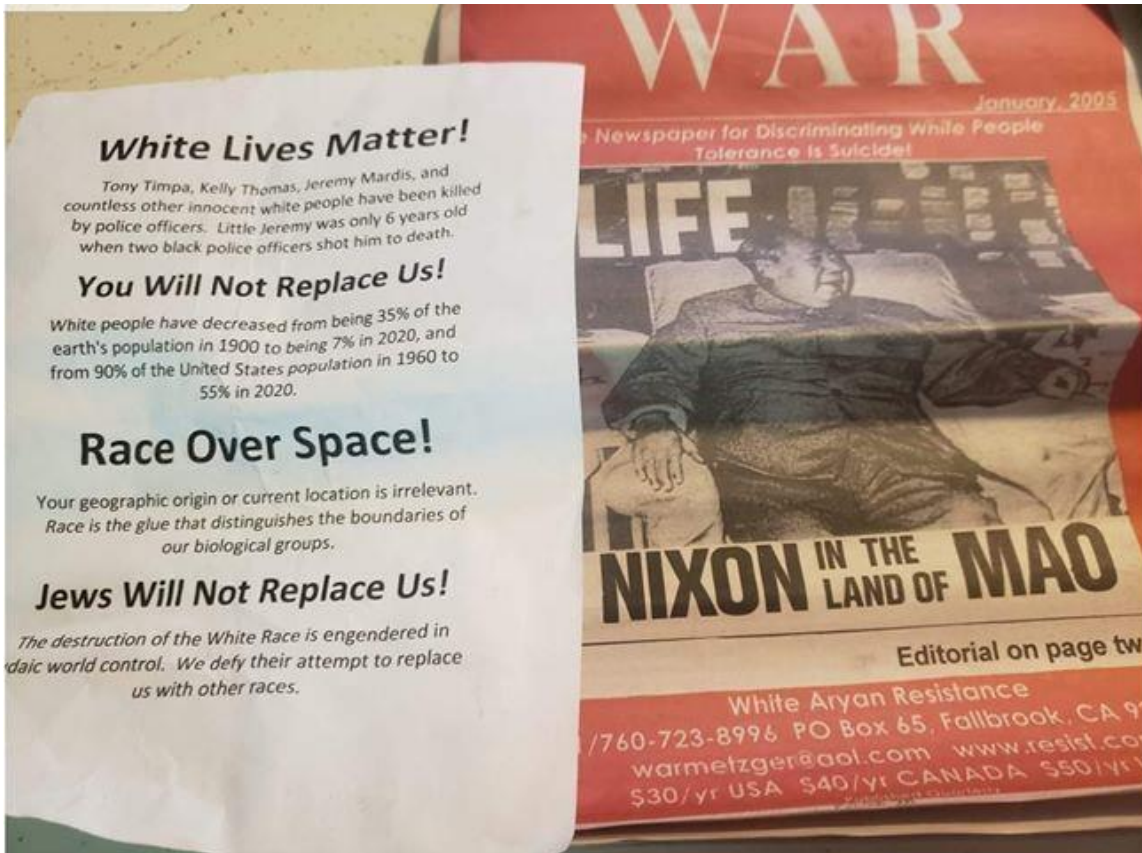
I've seen two protests added that are taking place in delafield and mequon this weekend !

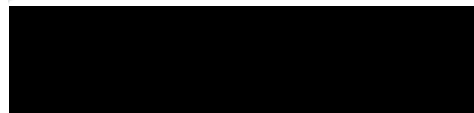

- Anti-Semitic / White Supremacist Literature Distribution
Over the weekend of 06/13/2020 and 06/14/2020, dozens of anti-Semitic / “White Aryan Resistance” flyers were distributed / posted in the Jackson Park neighborhood of Milwaukee (area around S. 43rd and W. Oklahoma). **Local media has been reporting that the same flyers were distributed in West Allis during the same period.**



- **Use Of Discord / Encrypted Communications**



Hi new MKE Marches members!

Some of you may be wondering, "what's Discord?" and "do I really need that?"

So here's a little info for ya, and you can decide for yourself:

- Discord is an external, encrypted server, accessible on your mobile as a free app, or on your computer at home. (we see you FB 🙄)
- It allows for safe, anonymous, and streamlined communications for all logistical coordination.
- It provides a place for livestreams and live protest updates, as well as a directory for info on everything from 'how to be a white ally' to phone numbers of pro-bono lawyers in 'legal help', easily accessible when you need it most.
- Best of all, it allows for different Action Groups (medical, legal, political advocates, musicians, visual artists, etc.) to coordinate, all within one coordinated server.
- Our Supply Needs Coordinator, Transportation Co-coordinators, and Volunteer Coordinators help keep the Supply Depots stocked, the Action Groups' needs met, and the demonstrations populated with YOU, BLM allies.

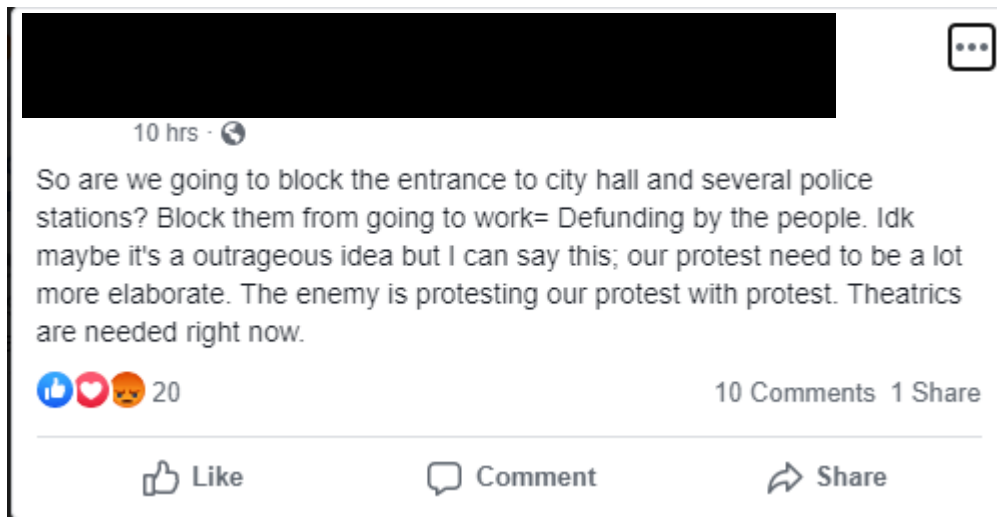
We've vetted folks to come into MKE Marches FB group, and we do a second round of vetting to gain access to the MKE Marches Discord Server, so it's pretty dang safe.

- The context of the below post suggested that this is specifically concerning possible action on Juneteenth Day (June 19th), but is included here for situational awareness in the meantime.



- On 06/12/2020, MPD District 6 officers were investigating an incident in the area of S. 10th and W. Oklahoma when they observed a mid-2000s's green Ford Ranger with red tape concealing the registration and red tape markings in the shape of a medical cross. Multiple male occupants were observed in the vehicle cab and in the truck bed. All occupants were wearing face masks and one wore what appeared to be a Kevlar-type helmet. The vehicle stopped near approximately S. 10th St. and W. Manitoba, where the occupants disembarked and congregated. Shortly thereafter, a green laser light was observed being aimed toward the squad vehicles. At least one subject (White Male, LSW Green hooded sweatshirt, tan shorts, and a Green Bay Packer bandana over his face) was also observed filming officers with his cell phone.
