THE BELOW NAMED COMPLAINANT BEING DULY SWORN, ON INFORMATION AND BELIEF STATES THAT:

Count 1: ATTEMPT FIRST DEGREE INTENTIONAL HOMICIDE - PTAC, AS A PARTY TO A CRIME, USE OF A DANGEROUS WEAPON (As to defendant Afrisawn Tywan Dedrick)

The above-named defendant on or about Friday, January 6, 2023, at 4010 North 100th Street, in the City of Milwaukee, Milwaukee County, Wisconsin, as a party to a crime, attempted to cause the death of another, another human being, with intent to kill that person, contrary to sec. 940.01(1)(a), 939.50(3)(a), 939.32, 939.05, 939.63(1)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendants may be sentenced to a term of imprisonment not to exceed sixty (60) years.

And further, invoking the provisions of sec. 939.63(1)(b) Wis. Stats., because the defendant committed this offense while using a dangerous weapon, the maximum term of imprisonment for the felony may be increased by not more than 5 years.

Count 2: ENDANGERING SAFETY BY USE OF DANGEROUS WEAPON (FROM VEHICLE, AT OR TOWARD BUILDING OR VEHICLE) - PTAC, AS A PARTY TO A CRIME (As to defendant Afrisawn Tywan Dedrick)

The above-named defendant on or about Friday, January 6, 2023, at 4010 North 100th Street, in the City of Milwaukee, Milwaukee County, Wisconsin, as a party to a crime, did intentionally discharge a firearm toward another vehicle, from a vehicle while on a highway as defined in s. 340.01(22), contrary to sec. 941.20(3)(a)2, 939.50(3)(f), 939.05 Wis. Stats.

Upon conviction for this offense, a Class F Felony, the defendants may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than twelve (12) years and six (6) months, or both.

Count 3: POSSESSION OF A FIREARM BY A FELON (As to defendant Afrisawn Tywan Dedrick)

The above-named defendant on or about Friday, January 6, 2023, at 4010 North 100th Street, in the City of Milwaukee, Milwaukee County, Wisconsin, did possess a firearm, having been convicted of a felony in this state, contrary to sec. 941.29(1m)(a), 939.50(3)(g) Wis. Stats.

Upon conviction for this offense, a Class G Felony, the defendants may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than ten (10) years, or both.

Count 4: DRIVE OR OPERATE A VEHICLE WITHOUT OWNER'S CONSENT (As to defendant Afrisawn Tywan Dedrick)

The above-named defendant on or about Friday, January 6, 2023, at 3000 North Sherman Boulevard, in the City of Milwaukee, Milwaukee County, Wisconsin, did intentionally drive or operate a vehicle, a Ford Fusion with license plate ACD-4389, without the consent of the owner, CKM and PJM, contrary to sec. 943.23(3), 939.50(3)(i) Wis. Stats.

Upon conviction for this offense, a Class I Felony, the defendants may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

Count 5: FLEE OR ELUDE AN OFFICER (As to defendant Afrisawn Tywan Dedrick)

The above-named defendant on or about Friday, January 6, 2023, at 3000 North Sherman Boulevard, in the City of Milwaukee, Milwaukee County, Wisconsin, while operating a motor vehicle on a highway, after having received a visual or audible signal from a traffic officer, federal law enforcement officer, or marked or unmarked police vehicle that the operator knew or reasonably should have known was being operated by a law enforcement officer, did knowingly flee or attempt to elude a traffic officer by increasing the speed of the vehicle in an attempt to flee, contrary to sec. 346.04(3), 939.50(3)(i) Wis. Stats.

Upon conviction for this offense, a Class I Felony, the defendants may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

And furthermore, invoking the provisions of Wisconsin Statute 343.31(3)(d)1, upon conviction the department shall revoke the defendant's operating privileges for 6 months.

And the defendant may also be subject to additional collateral consequences upon conviction, including revocation of operating privileges, assessment and treatment requirements, and future restrictions on operation of motor vehicles under Wisconsin Statute 343.31(1m).

Count 6: BAIL JUMPING (FELONY) (As to defendant Afrisawn Tywan Dedrick)

The above-named defendant on or about Friday, January 6, 2023, at 3000 North Sherman Boulevard, in the City of Milwaukee, Milwaukee County, Wisconsin, having been charged with a felony and released from custody under Chapter 969 of the Wisconsin Statutes, did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b), 939.50(3)(h) Wis. Stats.

Upon conviction for this offense, a Class H Felony, the defendants may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

Count 7: BAIL JUMPING (FELONY) (As to defendant Afrisawn Tywan Dedrick)

The above-named defendant on or about Friday, January 6, 2023, at 3000 North Sherman Boulevard, in the City of Milwaukee, Milwaukee County, Wisconsin, having been charged with a felony and released from custody under Chapter 969 of the Wisconsin Statutes, did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b), 939.50(3)(h) Wis. Stats.

Upon conviction for this offense, a Class H Felony, the defendants may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

Count 8: BAIL JUMPING (FELONY) (As to defendant Afrisawn Tywan Dedrick)

The above-named defendant on or about Friday, January 6, 2023, at 3000 North Sherman Boulevard, in the City of Milwaukee, Milwaukee County, Wisconsin, having been charged with a felony and released from custody under Chapter 969 of the Wisconsin Statutes, did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b), 939.50(3)(h) Wis. Stats.

Upon conviction for this offense, a Class H Felony, the defendants may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

Count 9: ATTEMPT FIRST DEGREE INTENTIONAL HOMICIDE - PTAC, AS A PARTY TO A CRIME, USE OF A DANGEROUS WEAPON (As to defendant Tysheonna Marie Jones)

The above-named defendant on or about Friday, January 6, 2023, at 4010 North 100th Street, in the City of Milwaukee, Milwaukee County, Wisconsin, as a party to a crime, attempted to cause the death of another, another human being, with intent to kill that person, contrary to sec. 940.01(1)(a), 939.50(3)(a), 939.32, 939.05, 939.63(1)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendants may be sentenced to a term of imprisonment not to exceed sixty (60) years.

And further, invoking the provisions of sec. 939.63(1)(b) Wis. Stats., because the defendant committed this offense while using a dangerous weapon, the maximum term of imprisonment for the felony may be increased by not more than 5 years.

Count 10: ENDANGERING SAFETY BY USE OF DANGEROUS WEAPON (FROM VEHICLE, AT OR TOWARD BUILDING OR VEHICLE) - PTAC, AS A PARTY TO A CRIME (As to defendant Tysheonna Marie Jones)

The above-named defendant on or about Friday, January 6, 2023, at 4010 North 100th Street, in the City of Milwaukee, Milwaukee County, Wisconsin, as a party to a crime, did intentionally discharge a firearm toward another vehicle, from a vehicle while on a highway as defined in s. 340.01(22), contrary to sec. 941.20(3)(a)2, 939.50(3)(f), 939.05 Wis. Stats.

Upon conviction for this offense, a Class F Felony, the defendants may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than twelve (12) years and six (6) months, or both.

Probable Cause:

Complainant is a City of Milwaukee Police Officer and bases this complaint on the reports of multiple Milwaukee Police Officers, describing the investigation into an incident in which officers were

shot at in the area of 4010 N. 100th Street in the City and County of Milwaukee. Those reports reveal the following.

On January 6, 2023, Detective Daniel O'Connell interviewed PO Benjamin Haas, at the District Seven Police Station after the shooting. At the time of the shooting, PO Haas was assigned to a fully marked MPD vehicle that was equipped with lights and sirens. PO Haas with his regular partner PO Shemar Moore. PO Moore was the driver in the squad and PO Haas was the passenger.

At approximately 2:40 a.m. that morning, PO Haas and PO Moore were informed by squad 7369 (PO Blake Laufenberg and PO Charles Worthington) that there was a vehicle in Sherman Park after park hours. Officers determined that the vehicle, a 2017 Blue Ford Fusion with Wisconsin license plate ACD-4389, had previously been reported stolen from West Bend. PO Haas observed the vehicle disregard a stop sign on Sherman Boulevard and W. Auer Avenue and proceed at a high rate of speed.

Near the intersection of W. Burleigh Avenue and N. Sherman Boulevard, in the City and County of Milwaukee, PO Moore activated the red and blue emergency lights and sirens to stop the vehicle. The vehicle then accelerated away from them at a high rate of speed. During the pursuit the Ford Fusion extinguished its headlights. At one point during the pursuit the Ford Fusion performed a U-Turn. PO Haas was able to see in the vehicle as it was in close proximity after making the U-Turn. He observed that there were two occupants in the vehicle, a driver and a front passenger. PO Haas observed the driver to be an African American male, but could not determine the race or gender of the passenger.

The pursuit covered approximately 7.4 miles. During the pursuit, the Fusion reached speeds of over 70 miles per hour. It disregarded several traffic signs and traffic lights during the pursuit. The pursuit path was as follows:

- South on Sherman Blvd from Burleigh.
- East on Clark from Sherman.
- North on Grant from Clark.
- West on Center from Grant.
- West on Lisbon from Center
- U-turn on Lisbon 81st to go east on Lisbon.
- North on 76th from Lisbon.
- West on Keefe from 76th.
- West on Lisbon from Keefe.
- North on 100th from Lisbon.
- West on Hampton from 100th

At the 4000 block of N. 100th Street, PO Haas saw the driver of the Ford Fusion point a gun out the driver's side window and fire what he estimated to be five or six shots at the squad car he and PO Moore were in. A few second later, PO Haas observed the passenger stick a hand out the window and shoot an additional five or six shots at the squad car. PO Haas reported that he could hear what sounded like bullets hitting the pavement as the shots were being fired. Shortly thereafter a Sergeant ordered the pursuit be terminated after the Ford Fusion turned on Hampton Avenue.

The squad car that PO Moore was operating and PO Haas was the passenger in was equipped with a squad camera that includes sound. That camera depicts the squad pursuing the Ford Fusion. Just

after the Ford Fusion crosses the intersection of Capitol Drive heading north on N. 100th Street, muzzle flashes are apparent coming out of the driver's side front window of the vehicle. It sounds like there are 5 shots, and the muzzle flashes appear to be coming in the direction of the squad car. A few seconds later, additional shots, are visible and audible coming from the passenger side of the vehicle.

Officers located a total of 8 casings in the roadway between the 4000 block and the 4200 block of N. 100th Street. The casings were spread over an area of approximately 1,400 feet. All 8 casings were 9 mm casings. Preliminary analysis showed that all 8 casings were fired from the same firearm.

Around 6 a.m. the morning of January 6, 2023, officers were dispatched to a call at 2213 N. Himount Boulevard, for a call that an unknown vehicle had been left in the driveway. At that location officers located the Ford Fusion with plate number ACD-4389. That vehicle was processed for latent fingerprints and DNA. Two prints were recovered that were of sufficient quality for comparison, both of those prints are matches to Defendant Afrishawn Dedrick. His left index finger print was found on the exterior of the driver's door, and his right middle/right palm prints were found on the roof of the vehicle above the driver's door.

Officers observed bullet strikes to the vehicle. One was along the driver's side rear door of the vehicle. It appeared to be angled as if a firearm was fired along the driver's side of the vehicle, from the front of the vehicle toward the rear. Further bullet strikes inside the vehicle show that the bullet travelled at an angle into the vehicle and ricocheted, going through the back seat of the vehicle. The second bullet strike to the exterior of the vehicle was along the frame between the front driver's side and rear driver's side doors, and appeared to be fired in a trajectory from the front of the vehicle toward the rear. The trajectory of strikes inside the vehicle suggests that the bullet ricocheted inside the vehicle. The rear windshield of the Ford Fusion was found to be shattered. The apparent trajectory from the bullet strikes is consistent with shots being fired toward the pursuing squad car during the chase.

Officers recovered the "Infotainment Center" from the Ford Fusion. That type of device contains a large amount of data, including recording what phone numbers are connecting to the vehicle via Bluetooth devices. That system recorded 16 phone calls were made in the vehicle between 1 a.m. and 3 a.m. on January 6, 2023. Fourteen phone calls, the last of which was made at 2:04 a.m., were made by a device with number (920)203-0629. One call, made after the shooting at 2:56 a.m., was made by a device with phone number (414)553-8363. A check of databases available to law enforcement showed that (920)203-0629 is a number associated with Defendant Dedrick, while (414)553-8363, is associated with Defendant Tysheonna Jones. There was one additional call from an unidentified device.

Officers spoke with the registered owners of the Ford Fusion, CKM, dob 5/14/83, and PJM, dob 11/21/1982. Both of them stated that they did not know either Defendant, and did not give the permission to drive their vehicle.

Officers recovered surveillance video from a gas station at 5758 W. Appleton Avenue from around 2:16 a.m. on January 6, 2023. In that video the Ford Fusion is visible in the parking lot. A female exits the front passenger door of the vehicle. She goes inside and makes a purchase using a Wisconsin EBT Card. The Wisconsin Benefits Department provide information that the card used belongs to Defendant Dedrick. In a later mirandized interview, Defendant Jones identified herself as the woman in the video, and confirmed that Defendant Dedrick was driving the car.

On January 10, 2023, Milwaukee Police Officers, Wood County Sheriff's Deputies, and other local law enforcement located Defendant Dedrick and Defendant Jones in Wisconsin Rapids, Wisconsin, at 5810 N. 73rd Street. During a search of that residence, officers located a Glock 26GEN4 9 mm semi-automatic pistol. Preliminary analysis of that firearm showed that it fired the 8 casings that were located on the roadway at the site of the shooting. Officers also located a Samsung cell phone with number (414)553-8363 at that residence. In a later mirandized interview, Defendant Jones confirmed that the phone belongs to her and that is her phone number.

Defendant Dedrick Bail

Complainant further bases this complaint on review of CCAP records in Milwaukee County case number 20CF2901. In that case, Defendant Dedrick is charged with Possess Firearm – Convicted of a Felony in violation of Wis. Stat. § 941.29(1m)(a), a felony offense. The Defendant was released on bail with a condition that he not commit any new crimes. That condition was in effect on January 6, 2023.

Complainant further bases this complaint on review of CCAP records in Milwaukee County case number 21CF4566. In that case, Defendant Dedrick is charged with Bail Jumping – Felony, in violation of Wis. Stat. § 946.49(1)(b) and Vehicle Operator Flee/Elude Officer in violation of Wis. Stat. § 364.04(3), both felony offenses. The Defendant was released on bail with a condition that he not commit any new crimes. That condition was in effect on January 6, 2023.

Complainant further bases this complaint on review of CCAP records in Milwaukee County case number 21CF4566. In that case, Defendant Dedrick is charged with Vehicle Operator Flee/Elude Officer in violation of Wis. Stat. § 364.04(3), Possess w/Intent Heroin in violation of Wis. Stat. § 961.41(1m)(d)2, and 2nd-Degreee Recklessly Endangering Safety in violation of Wis. Stat. § 941.30(2), all of which are felony offenses. The Defendant was released on bail with a condition that he not commit any new crimes. That condition was in effect on January 6, 2023.

Defendant Dedrick Prior Felony

Complainant further bases this complaint on review of CCAP records in Milwaukee County case number 18CF5. In that case, on March 22, 2018, Defendant Dedrick was convicted of Operator Flee/Elude Officer-Bodily Harm or Property Damage in violation of Wis. Stat. § 364.04(3), a class H felony. That conviction remains of record and unreversed.
