## **REQUEST**

Requesting recommendation of the Other SDoH subgroup projects for \$1,374,803 within the Community Support Expenditure Category for American Rescue Plan Act (ARPA) funding consideration.

## **POLICY**

Milwaukee County Board file 21-555: "A resolution to create a Task Force to review and recommend funding allocations to the Milwaukee County Board of Supervisors for monies received by the County in the Federal American Rescue Plan Act of 2021"

### **BACKGROUND**

Milwaukee County received \$183 million between 2021-24 in federal ARPA aid. Approximately \$40,415,339 has been allotted for Community Support projects.

The Community Support Service Area subgroups were established to generate project-level allocation recommendations to respond to economic harms to workers, families, small businesses, impacted industries, and the public sector in Milwaukee County.

The Other SDoH subgroup was formed with subject matter experts following the Community Support Service Area Subgroup Charter. Membership includes the following individuals:

In December 2022 the subgroup reviewed the UpStart Kitchen Café and the Sherman Park Re-Imagined projects received from external sources to support Milwaukee County's recovery in this service area. The subgroup followed the criteria set by the ARPA Task Force on September 2, 2021, to recommend these projects as high priority projects.

#### PRIORITIZED PROJECTS

The high-ranking project in this service area is listed below for recommendation. Please also note the attached project proposals (Attachment A & B), the criteria scoring rubric (Attachment C), and the Service Area subgroup review summary (Attachment D) provides further detail.

UpStart Kitchen Café	Upstart Kitchen serves as an incubator for entrepreneurs who want to start or grow their food-oriented businesses. UpStart provides affordable, state-of-the-art, fully-equipped, and code-compliant commercial kitchen space, and also provides supportive services, training, mentoring, and community connections to help businesses succeed. Business resources and technical assistance, including business planning, proposal writing and coaching, is provided by UpStart and partner organizations. Funding will support three additional UpStart kitchen facilities in Milwaukee County.	\$412,500
Sherman Park Re- Imagined	Sherman Park Re-Imagined will improve healthy child and family environments, reduce the need for community violence intervention, reduce stormwater runoff and improve clean water conditions within Milwaukee Count. The project will improve the safety, vibrancy, and vitality of Sherman Park neighborhood residents, City of Milwaukee youth, and Boys & Girls Clubs of Greater Milwaukee's Club members and families. The project will relocate the waste management area and remediate drainage issues.	\$962,303
