The court has learned that Milwaukee County Circuit Court Judge Hannah C. Dugan has been charged with two federal criminal offenses, one of which is a felony and one of which is a misdemeanor. This court is charged in the Wisconsin Constitution with exercising superintending and administrative authority over the courts of this state. In the exercise of that constitutional authority and in order to uphold the public's confidence in the courts of this state during the pendency of the criminal proceeding against Judge Dugan, we conclude, on our own motion, that it is in the public interest that she be temporarily relieved of her official duties. IT IS ORDERED, in the exercise of the court's superintending and administrative authority over all courts in the state, Wis. Const. art. Dugan is temporarily prohibited from exercising the powers of a circuit court judge in the State of Wisconsin, effective the date of this order and until further order of the court.
