THE BELOW NAMED COMPLAINANT BEING DULY SWORN, ON INFORMATION AND BELIEF STATES THAT:

### **Count 1: FIRST DEGREE INTENTIONAL HOMICIDE**

The above-named defendant on or about Sunday, October 19, 2025, at 4398 North 27th Street, in the City of Milwaukee, Milwaukee County, Wisconsin, did cause the death of MCS, another human being, with intent to kill that person, contrary to sec. 940.01(1)(a), 939.50(3)(a) Wis. Stats.

Upon conviction for this offense, a Class A Felony, the defendant shall be sentenced to imprisonment for life.

#### **Count 2: FIRST DEGREE INTENTIONAL HOMICIDE**

The above-named defendant on or about Sunday, October 19, 2025, at 4398 North 27th Street, in the City of Milwaukee, Milwaukee County, Wisconsin, did cause the death of SNL, another human being, with intent to kill that person, contrary to sec. 940.01(1)(a), 939.50(3)(a) Wis. Stats.

Upon conviction for this offense, a Class A Felony, the defendant shall be sentenced to imprisonment for life.

#### **Count 3: FIRST DEGREE INTENTIONAL HOMICIDE**

The above-named defendant on or about Sunday, October 19, 2025, at 4656 North 31st Street, in the City of Milwaukee, Milwaukee County, Wisconsin, did cause the death of LKR, another human being, with intent to kill that person, contrary to sec. 940.01(1)(a), 939.50(3)(a) Wis. Stats.

Upon conviction for this offense, a Class A Felony, the defendant shall be sentenced to imprisonment for life.

#### **Probable Cause:**

Complainant is an employee of Milwaukee Police Department and bases this complaint on information and belief and on a review of official police reports prepared by Agency Name Police Officers which are the kind Complainant has used in the past and found to be truthful and reliable and which Complainant knows were prepared in the ordinary and regular course of police business.

## As to Counts 1 and 2:

# October 19, 2025, 9:20 p.m. Response to Homicides at 4398 N. 27th Street

On October 19, 2025, at approximately 9:23 p.m., Officers Kyle Labensky and Luiz Mendoza were dispatched to 4398 N. 27<sup>th</sup> Street, City and County of Milwaukee, for a shooting call for service. Upon arrival, the Officers observed that there were two separate shooting victims. Officer Labensky began to render aid to the male victim, later identified as Marcus Smith. Officer Labensky observed that Smith was bleeding from his head, and did not have a pulse. Officer Labensky began CPR on Smith until the Milwaukee Fire Department arrived on scene and took over. Despite lifesaving measures, Smith was pronounced deceased at 9:46 p.m. Smith was conveyed to the Milwaukee County Medical Examiner's Office for an autopsy, whereupon Dr. Brian Linert conducted an autopsy. Dr. Linert determined the cause of Smith's death to be a gunshot wound of the head.

Officer Mendoza began rendering aid to a female victim, later identified as Sandra Lee. Officer Mendoza observed that Lee was pulseless, not breathing, and bleeding from her face. Officer Mendoza began CPR on Lee until the Milwaukee Fire Department arrived on scene and took over. Despite lifesaving measures, Lee was pronounced deceased at 9:45 p.m. Lee was conveyed to the Milwaukee County Medical Examiner's Office for an autopsy, whereupon Dr. Brian Linert conducted an autopsy. Dr. Linert determined the cause of Lee's death to be multiple gunshot wounds to the back and scalp.

While conducting scene security, Officer Labensky observed a woman, later identified as Witness #2, running towards and coming close to entering the crime scene. Witness #2 stated that the person who just killed Smith and Lee was inside the apartment building at N. 29<sup>th</sup> Street and W. Atkinson Avenue. Witness #2 stated that he did not have a shirt on, was wearing jogging pants, and she saw him with a firearm.

On October 19, 2025, at approximately 9:35 p.m., Detective Taylor Carloni responded to 4398 N. 27<sup>th</sup> Street, to process the scene. Det. Carloni located eight spent 9 mm cartridge casings, which were placed on inventory.

#### Video Recovered from 4402 N. 27<sup>th</sup> Street.

Video surveillance footage was recovered from 4402 N. 27<sup>th</sup> Street, which captured the majority of the incident. The surveillance video depicts the suspect wearing a black and gray hooded sweatshirt with various designs, black jogging pants, and multicolored Puma shoes. As noted below, a surveillance still of this subject was identified by Witness #1 and Witness #2 as the defendant.

Upon reviewing the surveillance footage, Detectives observed that the defendant and Lee are observed on surveillance camera outside and inside 4402 N. 27<sup>th</sup> Street from 4:00 p.m. until the time of the homicide (9:20 p.m.). At approximately 7:08 p.m., Smith is observed outside the store. The defendant, Smith, and Lee are all depicted on surveillance until the time of the homicide, along with other store patrons.

At 9:13 pm., Smith is observed walking southbound on the sidewalk towards a group of people in front of the store. At 9:19 p.m., the lower portion of the defendant's body is observed standing next to the lower portion of Smith's body, as Lee is walking southbound on the sidewalk. Smith's hat is observed falling on the sidewalk, and Smith is observed falling to the ground and lying on the left side of his body.

At 9:20 p.m., Lee is observed running southbound, away from the defendant, as he is chasing her with what appears to be a gun in his right hand, outstretched towards Lee. Multiple gun flashes are observed to be coming from the gun while it is pointed at Lee, before she falls onto the sidewalk on the corner. The defendant is observed running up to Lee after she falls and then stands next to her body, just off camera. A shadow of the defendant is observed as it appears he repeatedly strikes Lee (Lee's head is off camera, but her feet are depicted on camera, and move in a manner consistent with her body being struck). The defendant is then observed running back on camera towards Smith, while

pointing his gun in Smith's direction, as Smith is lying on the ground. The defendant stands near Smith for several moments before running westbound on W. Atkinson Avenue, on the north side of the street.

#### **Witness Statements**

On October 19, 2025, at 10:26 p.m., Detective Justin Sokolowski interview Witness #1, who was working at the managers of Preachers, 4396 N. 27<sup>th</sup> Street. Witness #1 stated that he knows both Smith and Lee, and they frequent his shop. Witness #1 stated that on October 19, 2025, everyone left his business, and he closed his blinds. Witness #1 stated that shortly after, he heard over 4 gunshots. Witness #1 stated that he did not see who did it, but is hearing that "Mike" did it. Witness #1 stated that "Mike" is another individual who frequents his shops, and was at his shop on October 19, 2025.

Witness #1 described "Mike" as follows: a black male, 20's-30's, 5'06" – 5'07" in height, medium build, with a medium to short afro. Witness #1 stated that "Mike" was last seen wearing black pants, no shirt, and multi-colored Puma shoes. Witness #1 was shown a still photo of the subject depicted in surveillance footage committing the homicides. This still footage was immediately prior to the homicide, as he is walking on the sidewalk. Witness #1 identified the person depicted in the surveillance still as "Mike," the defendant.

On October 19, 20205, Detective Sokolowski spoke with Witness #2. Witness #2 ran up the homicide crime scene tape, and stated that the suspect is in her sister's apartment—2901 W. Atkinson Avenue, City and County of Milwaukee. Witness #2 stated that "Mike" came to the apartment building with a gun in his hand, and was acting crazy. Witness #2 stated that "Mike's" real name is Michael Williams. Witness #2 stated that "Mike" was wearing no shirt, black joggers, and colorful Puma shoes. Witness #2 stated that she was fearful and fled this location. Witness #2 stated that "Mike" does not have an apartment at 2901 W. Atkinson Avenue, and he just sleeps in the hallway or basement of the location. Witness #2 was shown the same still from surveillance footage of the suspect immediately prior to the incident, and identified the suspect as "Mike," the defendant.

#### **Arrest of the Defendant**

Officers Labensky, Mendoza, Constantine Spence, and Nicole Becerra Rivera responded to 2901 W. Atkinson Avenue, in an attempt to locate the suspect in this incident. Officer Spence made contact with **above-referenced defendant**, as he was exiting a rear door of the complex, near the alley. Officers noted that the defendant had a strong odor of bleach on him while being taken into custody. While being taken into custody, the defendant stated that "he did the city a favor."

# Search of 2901 W. Atkinson Avenue, Apartment #3

Officers obtained a search warrant and conducted a search of 2901 W. Atkinson Avenue, apartment #3. Inside the apartment Officers located an open container of bleach on the windowsill. Officers also located a black t-shirt in the bathtub, which appeared to be drenched in suspected bleach.

This bleach bottle was processed for fingerprints, whereupon two latent prints were recovered, both of which were determined of sufficient quality in AFIS. Lift #2, recovered from the exterior of the bleach bottle, was identified as the defendant's left ring finger.

On October 20, 2025, Detective Alexander Klabunde searched the basement of 2901 W. Atkinson Avenue, and located a pair of multi-colored Puma brand tennis shoes, which were located in storage locker #8. These shoes had what appeared to be blood on them. Detective Joshua Nemeth interviewed Witness #3, who stated that he is the resident of apartment #8, but does not keep anything in his corresponding storage locker. Witness #3 stated that the Puma shoes do not belong to him.

#### As to Count 3:

## October 19, 2025, 10:26 p.m., Response to 4656 N. 31st Street Homicide

On October 19, 2025, at approximately 10:26 pm., Officers Delia Carrillo and Robert Bremer were dispatched to a shooting, at the address of 4656 N. 31<sup>st</sup> Street, City and County of Milwaukee. Officers were informed by the 911 caller that there was a person in a black Audi, who was non-responsive and stiff in the driver's seat of the vehicle. Upon arrival, Officer Carrillo observed a black Audi parked in front of 4656 N. 31<sup>st</sup> Street, which matched the description provided by the 911 caller. Officer Carrillo observed that there was an individual in the driver's seat of this Aud. Officer Bremer pulled the individual, identified as Lakendrick Roby, out of the vehicle, and began CPR until the Milwaukee Fire Department arrived on scene. Despite lifesaving measures, Roby was pronounced deceased at 10:50 p.m.

Roby was transported to the Milwaukee County Medical Examiner's Officer, whereupon Dr. Haaris Iqbal performed an autopsy on him. Dr. Iqbal determined Roby's cause of death to be multiple perforating gunshot wounds of the back.

Detective Mark Sheremeta conducted the scene investigation, and located five "FC 9mm Luger" stamped spent casings. Four of these casings were located inside the Audi, and one was located on the roof of the Audi.

## Complainant notes that 4643 N. 31st Street is located .4 miles from 4398 N. 27th Street.

#### **Witness Interviews**

Detective Tyler Pileggi spoke with the 911 caller, Witness #4, who stated that at approximately 10:17 p.m., she was upstairs in her residence when she heard one gunshot. Witness #4 stated that a few seconds later, she heard four more gunshots. Witness #4 stated that she got onto the floor with her son.

Detective Mark Sheremeta interviewed Witness #5, who stated that the above-referenced defendant is his uncle. Witness #5 stated that the defendant has been having mental health and drug abuse issues. Witness #5 states that he lives at 4652 N. 31<sup>st</sup> Street, along with other family members. Witness #5 stated that the defendant has been threatening him, along with other family members. Witness #5 stated that the defendant told family that God told the defendant to kill family, including Witness #5.

Complainant notes that the Audi in which Roby was discovered was parked in front of Witness #5's house.

#### Video Recovered from 4624 N. 31st Street

Detectives canvased the area of the homicide and located video from 4624 N. 31<sup>st</sup> Street. Detective Sheremeta reviewed this video, and notes that this video is in black and white, and captures the incident from a distance. This video shows two subjects near the black Audi which is parked to the north in front of 4656 N 31st Street on the east side of the street. Both subjects go from the house/sidewalk to the driver's side of the vehicle. The video then shows the suspect run through the street to the east sidewalk, before running past the cameras southbound on the east sidewalk toward W. Glendale Avenue in the direction of the location where the suspect was arrested a short time and distance later.

This video shows that the suspect is wearing black pants, a patterned sweatshirt, and patterned shoes. While this video is in black and white, Complainant notes that this clothing is consistent with the clothing the **above-referenced** defendant was wearing during the homicides of Lee and Smith.

#### As to all Counts:

The (8) 9 mm spent cartridge casings recovered from the 4398 N. 27<sup>th</sup> Street homicides, as well as the (5) 9mm casings recovered from the 4656 N. 31<sup>st</sup> Street homicide, were conveyed to the Fusion Division of the Milwaukee Police Department. A certified Integrated Ballistics Specialist conducted a preliminary analysis of both sets of these casings, and found them to be consistent with being fired from the same firearm. These casings will be sent to the Wisconsin State Crime Lab for analysis.
