



## PUBLIC HOUSING WAITING LIST OPENING

**PUBLIC HOUSING** is a federally subsidized housing program where tenants typically pay 30% of their monthly income towards rent. Please note, this waiting list is only for **PUBLIC HOUSING**. **The Housing Choice Voucher (Section 8) waiting list remains closed until further notice.**

### QUALIFICATIONS

To qualify for **PUBLIC HOUSING**, the Head of Household must be 18 years or older and the TOTAL household income must not exceed the limits indicated below:

#### INCOME LIMITS

(80% of Milwaukee County Median Income)

### HOW TO GET ON THE WAITING LIST

To add your name to the waiting list, you will need the following pieces of information for the Head of Household (anyone may register on behalf of the Head of Household) as well as the first and last name, date of birth, and gender for any additional members of the household:

- First and last name (for all household members)
- Date of birth (for all household members)
- Mailing address
- Social Security Number
- Phone number (including area code)
- Email address

All waiting list applications must be completed online at [waitlist.hacm.org](http://waitlist.hacm.org) using a computer, tablet or smartphone with an internet connection. If you do not have access to an internet-enabled device, public libraries have computers that are free for the public to use. **It is your responsibility to keep your contact information updated.**

After an individual applies for the waiting list, they will be contacted via email once their name is selected and invited to complete a full application to determine eligibility. Applicants are selected from the waiting list based on the date and time of their application. Due to a variety of factors, we cannot provide applicants with their position on the waiting list.

Please note that the majority of HACM's available **PUBLIC HOUSING** units are **one-bedroom apartments**. While waiting list applications for all unit sizes are welcome, the availability of larger units will be limited.
