THE BELOW NAMED COMPLAINANT BEING DULY SWORN, ON INFORMATION AND BELIEF STATES THAT:

Count 1: ATTEMPT FIRST DEGREE INTENTIONAL HOMICIDE, USE OF A DANGEROUS WEAPON, HABITUAL CRIMINALITY REPEATER (As to defendant Donte Lamont Gladney)

The above-named defendant on or about Thursday, June 12, 2025, at 4853 North 46th Street, Alley, in the City of Milwaukee, Milwaukee County, Wisconsin, attempted to cause the death of SRS, another human being, with intent to kill that person, contrary to sec. 940.01(1)(a), 939.50(3)(a), 939.32, 939.63(1)(b), 939.62(1)(c) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendants may be sentenced to a term of imprisonment not to exceed sixty (60) years.

And further, invoking the provisions of sec. 939.63(1)(b) Wis. Stats., because the defendant committed this offense while using a dangerous weapon, the maximum term of imprisonment for the felony may be increased by not more than 5 years.

And further, invoking the provisions of sec. 939.62(1)(c) Wis. Stats., because the defendant is a repeater, having been convicted of at least one felony during the five year period immediately preceding the commission of this offense, which remains of record and unreversed, the maximum term of imprisonment for this offense may be increased by not more than 6 years, if the prior conviction was a felony.

Count 2: POSSESSION OF A FIREARM BY A FELON, HABITUAL CRIMINALITY REPEATER (As to defendant Donte Lamont Gladney)

The above-named defendant on or about Thursday, June 12, 2025, at 4853 North 46th Street, Alley, in the City of Milwaukee, Milwaukee County, Wisconsin, did possess a firearm, having been convicted of a felony in this state, contrary to sec. 941.29(1m)(a), 939.50(3)(g), 939.62(1)(b) Wis. Stats.

Upon conviction for this offense, a Class G Felony, the defendants may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than ten (10) years, or both.

And further, invoking the provisions of sec. 939.62(1)(b) Wis. Stats., because the defendant is a repeater, having been convicted of at least one felony during the five year period immediately preceding the commission of this offense, which remains of record and unreversed, the maximum term of imprisonment for this offense may be increased by not more than 4 years, if the prior conviction was a felony.

Count 3: ENDANGERING SAFETY BY USE OF A DANGEROUS WEAPON (POINTING), HABITUAL CRIMINALITY REPEATER (As to defendant Donte Lamont Gladney)

The above-named defendant on or about Thursday, June 12, 2025, at 4522 West Hampton Avenue, in the City of Milwaukee, Milwaukee County, Wisconsin, did intentionally point a firearm toward another, contrary to sec. 941.20(1)(c), 939.51(3)(a), 939.62(1)(a) Wis. Stats.

Upon conviction for this offense, a Class A Misdemeanor, the defendants may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

And further, invoking the provisions of sec. 939.62(1)(a) Wis. Stats., because the defendant is a repeater, having been convicted of at least one felony during the five year period immediately preceding the commission of this offense, which remains of record and unreversed, the maximum term of imprisonment for this offense may be increased to not more than 2 years.

Count 4: OBSTRUCTING AN OFFICER, HABITUAL CRIMINALITY REPEATER (As to defendant Donte Lamont Gladney)

The above-named defendant on or about Thursday, June 12, 2025, at 4853 North 46th Street, Alley, in the City of Milwaukee, Milwaukee County, Wisconsin, did knowingly obstruct an officer, while such officer was doing an act in an official capacity and with lawful authority, contrary to sec. 946.41(1), 939.51(3)(a), 939.62(1)(a) Wis. Stats.

Upon conviction for this offense, a Class A Misdemeanor, the defendants may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

And further, invoking the provisions of sec. 939.62(1)(a) Wis. Stats., because the defendant is a repeater, having been convicted of at least one felony during the five year period immediately preceding the commission of this offense, which remains of record and unreversed, the maximum term of imprisonment for this offense may be increased to not more than 2 years.

Count 5: CARRYING A CONCEALED WEAPON (As to defendant Devin J Osborne)

The above-named defendant on or about Thursday, June 12, 2025, at 4522 West Hampton Avenue, in the City of Milwaukee, Milwaukee County, Wisconsin, not being a peace officer or other person defined in s. 941.23(2), did go armed with a concealed and dangerous weapon, a Polymer 80 9mm pistol, contrary to sec. 941.23(2), 939.51(3)(a) Wis. Stats.

Upon conviction for this offense, a Class A Misdemeanor, the defendants may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 6: ENDANGERING SAFETY BY USE OF A DANGEROUS WEAPON (POINTING) (As to defendant Devin J Osborne)

The above-named defendant on or about Thursday, June 12, 2025, at 4522 West Hampton Avenue, in the City of Milwaukee, Milwaukee County, Wisconsin, did intentionally point a firearm toward another, contrary to sec. 941.20(1)(c), 939.51(3)(a) Wis. Stats.

Upon conviction for this offense, a Class A Misdemeanor, the defendants may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 7: OBSTRUCTING AN OFFICER (As to defendant Devin J Osborne)

The above-named defendant on or about Thursday, June 12, 2025, at 4522 West Hampton Avenue, in the City of Milwaukee, Milwaukee County, Wisconsin, did knowingly obstruct an officer, while such officer was doing an act in an official capacity and with lawful authority, contrary to sec. 946.41(1), 939.51(3)(a) Wis. Stats.

Upon conviction for this offense, a Class A Misdemeanor, the defendants may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Probable Cause:

Complainant, Brian Maciejewski, is a Detective with the City of Milwaukee Police Department and bases this complaint on his personal knowledge of this investigation along with information from reports drafted by fellow law enforcement members, which he has relied upon in the past.

On June 12, 2025, Officer SS and his partner, Officer SM, were on patrol in the 4500 block of W. Hampton Avenue, Milwaukee. The officers were in full MPD police uniform and driving a marked MPD squad car. Officer SM and Officer SS were flagged down by a group of individuals congregated near the front door of 4522 W. Hampton Avenue. Officer SM conducted a U-turn at N. 45th Street and W. Hampton Avenue and traveled back westbound on W. Hampton Avenue. The officers then observed the group of individuals gesturing to them regarding subjects running northbound on N. 46th Street. Officer SS exited the passenger side of the squad car and pursued the subjects on foot. Officer SS encountered one of the subjects, later identified as Donte GLADNEY, in the 4800 block alley between N. 46th Street and N. 47th Street. GLADNEY shot Officer SS, as described below.

Officer SS sustained a gunshot wound to his lower left leg in the alley behind 4853 N. 46th Street, Milwaukee. It was determined that Officer SS fired 9 rounds from his department issued Glock 45 9mm semi-automatic handgun. It was determined that GLADNEY fired 4 shots from a 9mm Polymer 80 pistol found next to him. GLADNEY sustained a gunshot wound to his right knee.

Law enforcement located 9 MPD issued Speer 9mm Luger casings in the alley in the area of 4853 N. 46th Street. Law enforcement located 4 non-MPD issued 9mm casings (the following brands: Blazer, RP, WIN) in the same alley area. The distance between 3 of Officer SS's casings and 3 of GLADNEY's casings was approximately 56-58 feet. Law enforcement also recovered GLADNEY's firearm – a 9mm Polymer 80 pistol (no serial number) with a 15 round magazine. The firearm contained 11 unfired 9mm cartridges, along with 1 round in the chamber.

Officer SS stated that on June 12, 2025, he and Officer SM were on patrol in travelling eastbound in the 4600 block of W. Hampton Avenue as they approached the intersection of the N. 46th Street and W. Hampton Avenue, both officers observed two males wearing dark clothing and dark ski masks, on foot walking eastbound crossing N. 46th Street in the 4800 block. He added that they appeared to be walking with a purpose and seemed to be approaching several subjects standing near the front lawn of 4522 W. Hampton Avenue. Officer SS stated that based on these subject's actions, it led him to believe that a crime (perhaps a robbery) was going to occur and or was occurring. Officer SS stated that they were ultimately able to conduct a U-turn and began travelling westbound on W. Hampton Avenue and that they began to approach the subjects that were gathered near the front lawn of 4522 W. Hampton Avenue. Officer SS stated that at this point, he recalled that a female began to wave her arms up and down while pointing to the two males in the dark clothing and ski mask that they had just observed. These two males ran west bound across N. 46th Street and then northbound through the yards of the 4800 block between N. 46th Street and N. 47th Street.

Officer SS stated that Officer SM turned northbound from Hampton Avenue and they then went north on N. 46th Street until they reached the alley. Officer SS indicated that the squad lights and sirens were activated at this point and that he exited the squad car and began to pursue the subject/s on foot. Officer SS stated that one of the males appeared younger than the other. Officer SS stated that he was certain that he initially began the foot pursuit of the younger looking male on the west sidewalk in the 4800 block of N. 46th Street. Officer SS stated he then entered the gangway and into the yard of the second residence north of the alley, as that was the last direction of travelled that he had observed the male he was pursuing. Officer SS stated that he recalled that Officer SM stayed in their marked squad car and traveled westbound in the alley between N. 46th Street and N. 47th Street and that he heard Officer SM broadcast that the males were black males wearing dark clothing and armed with guns.

Officer SS stated that he lost sight of the subject he was pursuing and he began to check and search the yard he had entered, eventually entering the alley between N. 46th Street and N. 47th Street and began to travel north in the alley. Officer SS stated that while in the alley, he heard additional police officers responding to the area. Officer SS stated that he heard a broadcast from fellow officers about a subject was in the yards travelling northwest at an approximate address. He realized that he was close to the address that had been broadcasted (4853 N. 46th Street) and began to hear noises coming from that yard. He stated that he monitored that area and soon observed someone with a blue gun coming over the fence of that yard on the east side of the alley. Officer SS stated that he paused for a brief moment and was able to identify this person as non-law enforcement.

Officer SS stated that he remained in the alley and observed the male fully exit the yard and onto the alley. He stated that he observed the male subject in dark clothing and noticed that the male was armed with the blue handgun. He stated that once the subject was in the alley, he ordered the subject to drop the gun multiple times. Officer SS stated at this time he could see the subject down on the ground in a semi-seated position resting on his right side with the gun pointed toward him (Officer SS). Officer SS stated that he positioned himself near the fence along the west side of the alley. He estimated that the subject was approximately 20 feet to the north and east of him. Officer SS stated the ordered the subject to drop the gun multiple times as he attempted to take cover but there wasn't any place to do so. Officer SS stated he suddenly heard gunfire and could feel bullets whistle past him. Officer SS stated that he felt numbness to his left leg but did not realize that he had been shot immediately. Officer SS stated that he returned fire and discharged his firearm 4-8 times at the subject. Officer SS stated that he discharged

his weapon because he felt like he was in a life and death situation and he fired in order to stop the threat.

Officer SS stated that he stopped firing his gun once he observed the subject lying down on the ground with his arms extended to the north. Officer SS stated that he could see that the blue gun was no longer in the subject's hand but that the gun was still within arms-reach of the subject. Officer SS stated that he had his gun pointed at the subject and issued commands for the subject to remain down and not reach for the gun. Officer SS and Officer SM ordered the subject on the ground in order to apply handcuffs on the subject and place him into custody. Officer SS stated that he then realized that he had been shot and could feel blood on his leg and could see the blood on his pants leg and shoes. Officer SS stated that other officers assisted in putting a tourniquet on his leg. The subject was identified as GLADNEY.

Officer SM made a statement, describing what he observed. Officer SM indicated that he was the driver of the squad and that Officer SS was the passenger. Officer SM stated that he was driving at 47th and Hampton and did a U-turn at 45th and Hampton having seen Subject #1 and subject #2 come from the alley behind Stark Foods towards the apartment complex. Officer SM described them as follows:

- Subject #1: Black male, medium to dark complexion, 5'11, medium to heavy build, and last seen wearing a black "Pooh shiesty" covering everything but eyes; a black hooded sweatshirt, black jeans and dark colored shoes. Subject #1 was clutching front waist and, based off training and experience, believed to be armed.
- Subject #2: Black male, medium to dark complexion, 5'10-11, thin to medium build, wearing a "Pooh shiesty" mask, a black hooded sweatshirt with writing or a design, black pants and dark colored shoes. Also believe to be armed based on a clutching motion.

Officer SM observed five to ten people outside the apartment complex. Officer SM conducted a U-turn at 45th and was now traveling westbound. Officer SM observed Subjects #1 and #2 draw firearms. Officer SM state that he activated his lights and siren at east most corner of apartment. Officer SM stated that he observed Subject #1 and Subject #2 flee in a northwest direction and that the citizens pointed out the direction where they ran. Officer SM stated that the subjects ran to the T alley behind Stark Foods and he observed both subjects holding firearms in their right hands. Officer SM stated that Subject #2 dipped behind the alley and Subject #1, later identified as Donte GLADNEY, continued running north on the west side of the street and cut west.

Officer SM stated that Officer SS exited the squad and took off on foot after Subject #2, announcing "Police." Officer SM positioned the squad at T alley behind Stark Foods and began walking north when he observed Officer SS going northbound. Officer SM got back into his squad car and went northbound in T alley behind Stark Foods following behind Officer SS who was also going northbound. Officer SM stated that GLADNEY came through fence and fell forward and he drove the squad northbound. Officer SM stated that Officer SS was attempting to get the subject to surrender and that the subject was trying to get back up. Officer SM estimated that he was approximately 2-3 houses away at this point and trying to close distance to assist Officer SS. Officer SM stated that he heard a gunshot, observed smoke come from the gun of GLADNEY's gun, heard additional shots and saw smoke come from Officer SS's gun, consistent with gunfire.

Officer SM stated that after the first gunshot, he saw Officer SS shift his stance to left. Officer SM stated that he believes that GLADNEY shot approximately twice and that Officer SS shot approximately 3-4 times. Officer SM stated that he called out "shots fired" over radio, got to Officer SS, drew his pistol and told the subject to drop the gun. Officer SM stated that Officer SS told the subject to not reach for the gun and stated that GLADNEY shot him. Officer SM stated that he did not see any blood coming from Officer SS at that time and that Officer SS was maintaining cover while Officer SM handcuffed GLADNEY. Officer SM stated that he observed the gun on the ground and believed it to have a green colored slide and he told another officer to secure the firearm and ultimately located the gun on the seat of his squad car and he secured it in a paper bag. Officer SM stated that he broadcasted the direction of flight for Subject #2 and that GLADNEY would not provide his name.

Detective Jose Flores reviewed Officer SS's Body Worn Camera (BWC) and summarized it as follows:

- 18:46.37 (time of day)/00:30 (minute mark) - The video begins with Officer SS exiting the passenger side of his squad car. He runs northbound on the sidewalk, then turns westbound and navigates through a narrow gangway located between 4819 N. 46th Street and 4823 N. 46th Street. Upon reaching the end of the gangway, he enters the rear backyard area of 4819 N. 46th Street and he announces, "Police! Police!" Officer SS then approaches a detached garage, overgrown with grass and weeds, climbs over a small wooden fence, and through an open chain-link fence, reaching the alleyway where Officer SM is standing.
- 18:47.02 / 00:57 - Officer SS then goes to the west side of the alley and begins to jog northbound. A radio broadcast can be heard emanating from Officer SS's handheld radio, "Two black males. Black male, he has a gun, 4853, northbound."
- 18:47.23 / 01:18 - A subject wearing dark-colored clothing enters the alley from the east, North of Officer SS. Officer SS announces, "Get on the fucking ground! Get in the ground right now! Drop the gun! Drop the gun! Drop the gun!" Multiple gunshots can be heard. Officer SS announces, "Don't fucking move! Shots fired! Shots fired! Don't Fucking move! Don't fucking move! Don't Fucking move! Don't move. Don't move the fucking gun! I'm shot! Officer SS approaches the subject wearing dark-colored clothing as he's lying face down on the alley floor on his back. As Officer SS approaches the subject, a multi-colored handgun, with the barrel facing south toward Officer SS and the grip and back strap facing north, can be seen laying in the alley. Officer SS continues to announce, "Don't fucking move! You just fucking shot at me! You just shot me! I'm shot!"
- 18:47.51 / 01:45 – Officer SS takes control of the subject's left arm and assists with taking him into custody. Officer SS broadcasts, "88, one in custody. I'm shot in the left leg. We're at 4854; we should be in between 46 and 45." Officer SS sits on the ground and is being assessed by another Police Officer, who applies a tourniquet. Blood can be seen coming from his left shin and calf area.

- 18:50:12-19:00:52 / 04:05-14:47 - Officers assist Officer SS into the rear of a Milwaukee Police Department Squad and begin transporting him to Froedtert Hospital. Upon arrival, Officer SS is assisted out of the rear passenger side of the Milwaukee Police Department Squad by medical personnel onto a wheelchair, his left shin and calve area visibly bloodied.

Detective Dan O'Connell reviewed Officer Steven SM's BWC and summarized it as follows:

- The video begins with Officer SM operating their marked Milwaukee Police Department Squad car eastbound in the 4600 block of W Hampton Avenue.
- 18:46:20 (time of day)/00:14 (minute mark) – Officer SM performs a U-Turn at N 45th Street and W. Hampton Avenue to return westbound on W Hampton Avenue.
- 18:46:32/00:26 – Officer SM turns right to go northbound in the 4800 block of N 46th Street.
- 18:46:32/00:30 – Officer SM activates the emergency red and blue lights and audible siren of their marked squad as he turns westbound into the East/West alleyway between N. 46th Street and N. 47th Street.
- 18:46:38/00:31- Officer SS states he has a gun. Officer SM reaches to his mobile radio hand mic with his left hand.
- 18:46:39/00:33 – Officer SM broadcasts over the radio “they got guns, four six and Hampton, between 46, 47, 2 black males.” As he is broadcasting, he stops the squad car in the alleyway, allowing Officer SS to exit the squad and begin run on foot north on N. 46th Street. Officer SM continues west through the alleyway and parks the squad at the south end of the T-Intersection of the alleyway.
- 18:46:48/00:42 – Officer SM exits the squad car. As he is doing so, Officer SS can be heard announcing “Police! Police!” Officer SM then broadcasts “North of Hampton between four six and four seven.”
- 18:46:54/00:48 - Officer SM draws his firearm and begins to walk north through the alleyway.
- 18:46:59/00:53 – Officer SS emerges from the narrow gangway between 4819 and 4823 N. 46th Street. Officer SM asks Officer SS “Got him?”
- 18:47:04/00:57 - As Officer SM is returning to his squad car, he broadcasts over the radio “they went north on four six, I believe. Two black males, all black. Masked up”

- 18:47:12/01:06 - Officer SM enters the squad car. After he enters the squad, a radio broadcast from another officer can be heard “Black male, he’s got a gun. 4853 northbound.”
- 18:47:20/01:12 - Officer SM starts the squad and as he does so, another radio broadcast is heard “behind a house, 4853.” He reverses the squad and then travels north through the alleyway.
- 18:47:31/01:25 - The first gunshot can be heard as Officer SM is accelerating forward. Due to the angle of his body-worn camera, the viewer is unable to observe what is occurring during the shots being fired.
- 18:47:32/01:25 – Officer SS comes into view of the body-worn camera. He is standing in the middle of the alleyway and appears to be in an athletic, standing, firing position. GLADNEY is observed lying on the ground on the east side of the alleyway and appears to have his feet flat on the ground. Over the next few seconds, Officer SS moves to the east towards the fence line.
- 18:47:32/01:26 – Officer SM calls out shots fired over the radio.
- 18:47:35/01:29 – Officer SM stops the squad car and exits. He yells “Hands up! Hands up!” and begins to move north towards GLADNEY.
- 18:47:39/01:33 – Officer SS is heard broadcasting “Shots fired! Shots Fired!” Officer SM also broadcasts “Shots fired! Shots fired!” as they approach.
- 18:47:42/01:36 - Officer SM orders the suspect to “Don’t fucking move!” Both officers continue to move north towards GLADNEY who is now lying on his stomach with his arms spread out to the side and feet spread apart. As they move forwards they continue to give commands to the suspect to not move and not to reach for the gun.
- 18:47:49/01:43 – Officer SS announces, “I’m shot!”
- 18:47:52/01:46 – Officers SS and SM take control of GLADNEY’s left and right arms, respectively. Officer SM puts handcuffs on the suspect. Officer SS is exclaiming in pain from his gunshot wound. A black semi-automatic handgun can be seen lying on the ground a few feet away from where GLADNEY was taken into custody.
- 18:48:01/01:55 - Responding officers remove Officer SS from the area and begin to render aid to him in the alleyway south of where the suspect was located.
- 18:48:13/02:06 – Officer SM instructs Officer Jordan Roberson to take the firearm located next to GLADNEY and secure it in a squad.
- 18:48:24/02:18 - Officer SM puts on latex gloves and begins to render aid to GLADNEY.

- 18:48:32/02:26 – Officer SM broadcasts “There’s one more out, we don’t know where he went. Black male, thin build, all black. Should have a gun.”
- 18:48:46/02:40 - Officer SM broadcasts “88 we’re in the alley between, I believe, four eight and four seven possibly, four seven and four six. 4854 is the address next to us. We have an officer shot”... “I believe it’s between four six and four seven. We have an officer shot, white male about 30 years of age. He’s conscious and breathing. He’s hit in the left calf. We have a suspect shot, I believe. Black male” He then asks GLADNEY “Where you hit buddy?” GLADNEY responds, “In my leg.”
- 18:49:24/03:16 - Officer SM continues to broadcast, “We have a black male about 35 years of age, in custody. Conscious and breathing. Shot in the leg.” He then instructs the responding officers that there is one more suspect out and they should cover for him.
- Over the next several minutes Officer SM continues to direct responding officers, providing the description of the second suspect over the radio as the second suspect was unaccounted for.
- 18:52:27/06:21 – Officer SM returns to his squad car and broadcasts a description of the second suspect that was unaccounted for “Suspect Description: Black male, thin build, black jeans, black hoodie with some writing on the back. Thin build, mask. He was also armed with a gun. He’s gonna be between most likely, four six and four five. Last seen northbound from Hampton. They both ran in tandem.”
- 18:53:15/07:09 – Officer SM takes the suspect’s firearm that was placed on the driver’s seat in his squad and moves it to the trunk and places it in a brown paper bag. He returns to the driver’s door with the bag and broadcasts that the second suspect had white writing or a decal on the back of the hoodie he was wearing.
- 18:54:07/08:01 - Officer SM returns to the trunk of his squad with the brown paper bag and places the bag inside the trunk.
- 18:54:28/08:22 - Officer SM locks the squad after the trunk was closed by another officer, and he returns north through the alleyway.
- 18:55:57/09:51 - Officer SM remains on scene and explains what led up to the shooting to Sergeant Justin Schwarzhuber stating, "we see him and another dude masked up going towards the apartments on 45th and Hampton. Right on the corner where there's a group of people. It looks like they start upping guns on them. We pop a U-Turn and they all start pointing there, there, there. They run off when they see us. We see them running with guns."

Devin OSBORNE was arrested in the yard of 4832 N. 46th Street. He was wearing all black clothing and had dreadlocks. OSBORNE appeared flushed and out of breath. A black Polymer P80 semi-automatic pistol (no serial number), loaded with one 9mm unfired hollow point red tip Hornady cartridge in the chamber was located on the walkway directly to the west of the southwest corner of the residence in the backyard of 4823 N. 46th Street. The firearm did not have a magazine inserted. The magazine was recovered near the rear of 4823 N. 46th Street under a hose reel cart located on the south east corner of the gangway on the south side of that residence.

LLK stated that both subjects retrieved their firearms from their waistbands underneath their hooded sweatshirts, and that Suspect #1 stated, "don't nobody move," and demanded, "where the light-skinned nigga at?" LLK stated that the subjects, "upped their guns" on them, which meant that the two suspects pointed their firearms at LLK and the group. LLK stated that she told them, "please don't shoot me." LLK stated that both subjects lowered their black masks during the incident and she was able to see their faces. LLK stated that she had not seen the suspects prior to this and did not know who they were looking for. LLK stated that the altercation lasted seconds. LLK stated that this was scary and she could have lost her life. LLK stated that she could have been killed and that the suspects upped their guns so fast on them.

LLK stated that she had noticed police patrolling the area prior to the incident. LLK related that someone in their group called out, "here come Five-O," and LLK observed a police squad westbound on W. Hampton Avenue heading towards N. 46th Street. LLK related that it was a black marked Police SUV and pointed out a nearby Police Ford Escape, stating that it looked like that one. LLK stated that upon seeing the police, the two subjects ran a northwest direction on N. 46th Street in between the houses. LLK stated that she called out to the officers stating, "they ran over there between the houses." LLK stated that she did not yell about the guns, and could not recall or remember anyone else calling out about the guns. She related if someone else called out the guns, she didn't hear it. LLK confirmed that the police squad activated its lights and siren starting on W. Hampton Avenue and followed the subjects as they fled. LLK stated that the subjects were running in and out between the houses and that she observed one of the officers exit the squad car. She was not sure if the officer exited the driver or passenger side and could not describe the officer other than saying he was a male. LLK did not see the officer holding a gun and did not know if the suspects were still holding their own guns while they were running. LLK stated that she went back towards the apartment building, and while on the move, she heard 6 gunshots in a single grouping.

It should be noted that LLK did not make a positive identification when shown photo arrays containing GLADNEY and OSBORNE's photos.

GLADNEY was conveyed to Froedtert Hospital where he was treated for a gunshot wound to the right knee. His clothing was inventoried as follows: a black du-rag; a black t-shirt with red and white lettering and a pink teddy bear on the front; black jeans; and black Nike Air Max brand shoes. While at the hospital, GLADNEY made statements to the effect of, "the other guy ya'll got didn't have nothing to do with it, he just came with me. It was all me. It's all on me." GLADNEY stated he was at Stark Foods when an unidentified subject began arguing with him (GLADNEY). GLADNEY stated this subject kept grasping a firearm he had on his person during this argument. GLADNEY stated surveillance cameras at Stark Foods would have caught this interaction. GLADNEY stated he "came looking for the mother fucker" and stated "he brought the evil out in me."

GLADNEY made a *Mirandized* statement where he explained that on the morning of June 12, 2025, he worked at Pitney Bowes until 8am. He then went to his probation agent at 11:00 am for an appointment. After that he went to Stark Foods on Hampton Avenue. While inside the store, a light skinned black male in all black clothing and wearing a mask and clutching a gun made a comment to GLADNEY. GLADNEY stated that this was around 12:00 pm. He then went to his residence located at 5003 N. 46th Street. He stated that approximately an hour later he went back to Stark Foods and asked the workers there were the light skinned black male with the gun lived. They told him that this subject lives in the apartment complex with the rocks. GLADNEY claimed to be unarmed during these two incidents.

GLADNEY then went back home and decided to go find this subject later when it was getting dark. Later in the day, GLADNEY was home and his brother, Devin, was there. He told his brother to put on black clothing and come with him. GLADNEY stated that he and Devin were walking to the apartment building to find the subject from earlier in the day. As they made it to Hampton Avenue, he saw the police turning around and he began to run. He saw the police were coming after him and chasing him. He continued to run and saw numerous police in the area. GLADNEY stated that he continued to try and get away but he could not get over a gate. He stated that there were police everywhere and he got into the alley and heard an officer say don't move, or something like that. GLADNEY stated that he was still trying to run and he heard shots. GLADNEY stated he and the cop were shooting. He stated he did not know why he shot and did not know if he shot first or the cop shot first. GLADNEY stated no one else was involved in shooting the cop and acknowledged that shooting a someone could cause death or serious harm to the person.

GLADNEY stated that he purchased the gun from the street a month or two ago for \$500. He stated he knows he is a felon and should not have a firearm and stated previously he has prior convictions for being a felon and having a gun.

This complaint is further based on a *Mirandized* statement made by OSBORNE, who identified GLADNEY as his brother. OSBORNE stated the following: he was working and got a call and/or text from GLADNEY. GLADNEY told OSBORNE that he had been in Stark Foods and was approached by a black male "talking crazy," who was wearing all black clothing, a "Pooh shiesty" type mask and was armed with a small handgun. OSBORNE stated that when he got home from work, GLADNEY said that they should go to the store. OSBORNE armed himself with a black handgun that he has had for a couple of years and bought on the street. OSBORNE stated that it is a 9mm without a serial number and that he believes it is a Glock. OSBORNE stated that he tucked it under his left underarm and put a hooded sweatshirt over it. OSBORNE stated that he didn't know his brother had a gun nor did he know that GLADNEY left the house armed. OSBORNE stated that he carries his gun more frequently because of the recent events happening near Stark Foods.

OSBORNE stated that as they walked to the store, he was about to turn right off 46th Street and walk toward Stark Foods, when his brother pointed to the left at the apartment building at the opposite corner, and suggested that they go there instead. OSBORNE recalled that while they were in the front yard there that GLADNEY began demanding the light skinned male, who OSBOURN assumed to be the person that GLADNEY previously told him about. OSBORNE stated that he didn't believe that GLADNEY was going to do anything if they found this person, and believed that his brother was just going to talk to him.

OSBORNE recalled that as they were standing there, he observed a marked police squad approaching, and ran away because he had his gun. He knew his brother ran as well, but didn't know what direction or where he went. OSBORNE described how he ran through backyards and hopped fences, and stated that when he was running the magazine fell out of his gun. OSBORNE stated that he heard several shots fired, and didn't recall hearing anyone yelling prior to that.

OSBORNE explained that after the shots were fired, he took off his mask and hooded sweatshirt, explaining that he didn't want the police to mistakenly shoot him. OSBORNE also admitted that he dropped a gun in the yard prior to being found. OSBORNE recalled that after the shots were fired, he could hear people yelling "shots fired." The police found him hiding in the yard soon after. OSBORNE was shown a photo of the 9mm semi-automatic pistol was recovered near where he was arrested and identified it as his gun.

This complaint is further based upon a review of the Wisconsin Circuit Court Access Program (CCAP) which details that Donte GLADNEY was convicted in Milwaukee County Case Number 2021CF1797 of Possession of a Firearm by a Felon, Throw or Discharge Bodily Fluids at a Public Safety Worker on October 25, 2021. A third charge of Felony Bail Jumping was dismissed and read-in. GLADNEY was sentenced to a total 2 years of initial confinement and 2 years of extended supervision consecutive to 2020CF2078 on October 25, 2021. According to the Department of Corrections, GLADNEY was released on extended supervision on November 5, 2024, after a petition for sentence adjustment was granted over the State's objection. GLADNEY was also convicted in 2020CF2078 of Possession of a Firearm by a Felon and Endangering Safety by Use of a Dangerous Weapon (misdemeanor pointing) on October 25, 2021. A second count of both Possession of a Firearm by a Felon and Endangering Safety by Use of a Dangerous Weapon (misdemeanor pointing) were dismissed and read in. GLADNEY was sentenced to a total 2 years of initial confinement and 2 years of extended supervision consecutive on October 25, 2021. GLADNEY also has a felony conviction for Theft from Person in Milwaukee County Case Number 2011CF2910.
