THE BELOW NAMED COMPLAINANT BEING DULY SWORN, ON INFORMATION AND BELIEF STATES THAT:

Count 1: POSSESSION OF A FIREARM BY A FELON, HABITUAL CRIMINALITY REPEATER

The above-named defendant on or about Thursday, June 26, 2025, at or near 2203 North 25th Street, in the City of Milwaukee, Milwaukee County, Wisconsin, did possess a firearm, having been convicted of a felony in this state, contrary to sec. 941.29(1m)(a), 939.50(3)(g), 939.62(1)(b) Wis. Stats.

Upon conviction for this offense, **a Class G Felony**, the defendant may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than ten (10) years, or both.

And further, invoking the provisions of sec. 939.62(1)(b) Wis. Stats., because the defendant is a repeater, having been convicted of at least one felony during the five year period immediately preceding the commission of this offense, which remains of record and unreversed, the maximum term of imprisonment for this offense **may be increased by not more than 4 years**, if the prior conviction was a felony.

Probable Cause:

Complainant is a City of Milwaukee Police Officer and bases this complain upon the statements and reports of fellow City of Milwaukee Police Officers, as well as his own involvement in this investigation. That investigation and those reports and statements revealed the following:

Initial Investigation

Complainant states that on June 26, 2025, City of Milwaukee Police Officers were dispatched to a shots fired. Subsequent investigation revealed that a shootout occurred between a Tremaine Jones and people inside 2203 N. 25th Street, Apartment #2. City of Milwaukee Police Officers Kendall Corder and Christopher McCray were shot while responding. Officer Corder died.

Witness ECT

Complaint is further based upon the statement of witness ECT, who was present for much of the above incident. ECT stated that this began as a fight between females that live in the lower unit of the apartment complex at 2203 N. 25th Street, City and County of Milwaukee, State of Wisconsin, which includes witness JDJ, and another group of girls. ECT stated the day before the homicide, the two groups of girls fought.

ECT stated that on the day of the homicide, the second group of girls returned and began arguing with JDJ and her girls. However, this time, JDJ's group also included a black male with long dreads, later identified in this investigation as the above mentioned Defendant Bryshawn Tyler. ECT stated that because he thought it might lead to a fight, he took out his phone and started recording. While no fight occurred, he did record the male with JDJ's group hiding alongside 2203 N. 25th Street. In the video, this male, later identified as the above Defendant, is seen with dreadlocks, wearing a black shirt and red shorts, **and wearing a gray backpack in a reverse fashion on his chest**. The video shows this male to have a firearm in his waistband that had an extended magazine. Witness ECT stated that this male was armed with a **Glock handgun** in his waistband.

ECT stated the first group of females, including the armed male in the red shorts, later identified as the Defendant, then went inside 2203 N. 25th Street and that the other group of females indicated that they were calling someone to meet them. ECT stated that sometime later, he saw Tremaine Jones arrive.

ECT stated that the Tremaine Jones was armed with a black rifle-styled pistol and was standing in the street outside the apartment building. ECT stated that the Tremaine Jones began yelling for JDJ and the others to come outside and then fired a single shot into the air. EDT stated that Tremaine Jones then yelled for people to come outside again, and this time began firing again. EDT stated this time, he heard a second firing this time, which he believed was the male in the red shorts, later identified as the Defendant, firing back, possibly from inside the apartment.

Search Warrant At 2203 N. 25th Street

Complaint is further based upon the statement of City of Milwaukee Police Detective Thomas Klahorst, who states that on the evening of June 26th into the early morning hours of June 27th, he and other Milwaukee Police officers were conducting an investigation into the above incident. As part of that incident, he participated in a search warrant at Apartment #2 at 2203 N. 25th Street, City and County of Milwaukee, State of Wisconsin.

During that search warrant, several occupants were located including the above mentioned Defendant Bryshawn Tyler, who had dreadlocks and was wearing a black shirt and red shorts consistent with the armed suspect in the video taken by witness ECT.

During that same search warrant, in the bathroom, Detective Klahorst located a **gray Champion backpack**, consistent with one in the video provided by ECT. Detective Klahorst stated that inside this backpack officers recovered two .40 caliber handguns, one of which was a **Glock 23 .40 caliber handgun with an extended magazine**.

Detective Klahorst further states that a total of fired four .40 caliber cartridge casings were recovered inside the residence, consistent with firing back at Tremaine Jones when he shot at the residence. NIBIN analysis was consistent with each of the .40 caliber handguns firing two rounds each.

Statement of the Defendant

Complaint is further based upon the statement of the above mentioned Defendant who was shown still photos from the video taken by ECT and identified himself as the male with the dreadlocks in the red shorts carrying the gray backpack on his chest. Thus, the Defendant has admitted to being the person EDT said was carrying a Glock firearm with an extended magazine, that can be seen with an extended magazine in his pocket on the video, and the person carrying the backpack in which the two firearms were later located.

However, the Defendant denied knowing what was in the book bag and stated that he only had an extended magazine to make people think he is armed. The Defendant did not state who shot from the apartment.

Prior Felony Convictions

Complaint is further based upon review of CCAP records which indicate that on October 30, 2019, in Milwaukee County Case 19 CF 140, the Defendant was convicted of the felony offenses of Driver or Operate a Motor Vehicle Without Owner's Consent and First Degree Recklessly Endangering Safety in violations of 943.23(3) and 941.30(1) and thus the Defendant was prohibited from possessing a firearm and that said convictions were still in effect as of the time of this offense.

Complaint is further based upon review of CCAP records which indicate that on April 27, 2022, in Lincoln County Case 19 CF 252, the Defendant was convicted of the felony offense of Battery by Prisoner in violations of 940.20(1) and thus the Defendant is a Habitual Criminal.
